### PRE-AUTHORIZED TAX PAYMENT PLAN GUIDELINES

The pre-authorized tax payment plan is available to all property taxpayers whose tax account is paid up to date. Withdrawals come out the LAST BUSINESS DAY of every month and there are no service fees for this plan. Your monthly withdrawal is adjusted twice per year. A letter will be mailed to you in November with your monthly withdrawal from November to the following June (based on 1/12<sup>th</sup> of the current year's taxes). You will receive the final tax bill in July with your monthly withdrawal from July to October which reflects any changes in your yearly taxes. Final tax bills mailed in July should be kept for income tax purposes. Supplementary tax billings issued in the current year for additional taxes as a result of additions or improvements will be due and payable as issued. Monthly withdrawals will be adjusted to reflect any tax reductions due to assessment changes. It is YOUR responsibility to terminate the authorization if your bank account changes. It is YOUR responsibility to terminate the authorization if the property is sold. Any withdrawals returned due to non-sufficient funds will be subject to a \$25.00 administration fee. The City has the discretion to remove the account from the preauthorized plan at any time due to returned payments.
