# NEW BUSNESS

- 1. Set-up of year's meetings:
  - a. **March 28<sup>th</sup>, 2019** a review of the accessibility plan will take place. Voyageur Parallel Transit representative Bill Unger is to attend. Committee requested Tracey Tiersma provide an update on the Transit Strategic Plan and how MAAC can participate in the public consultation process.
  - b. May 23<sup>rd</sup>, 2019 scheduling of the audits to take place in June. Tracey Tiersma to send 2018 audit status sheets to committee; R. Tucker and A. Committee discussed companion animals and the possible amendment to the City's Animal Control By-Law 71-2011. Councillor S. Peters to provide committee with Council's decision and findings. Committee requested Tracey Tiersma to provide committee with the Council Report ES06-19.
