THAT: The Permit is conditional upon submission of a certificate of public liability and property damage insurance with a covering limit of \$5,000,000.00 to be provided by the affiliated organization certifying that the City of St. Thomas has been named as an additional insured for this event; and further,

THAT: The certificate of insurance be submitted to the Treasury Department prior to the start of the event; and further,

THAT: All other necessary requirements be fulfilled to the satisfaction of the Corporation of the City of St. Thomas.

Jurassic Park Game 4 Viewing NBA Finals - City of St. Thomas and MyFM - June 7th, 2019

The members discussed placement of the television and the fact that an on-site meeting was arranged.

The members discussed security and police presence at the event.

T. Calvert stated that there would be two paid duty officers at the event to control traffic and provide police presence.

The members discussed the road closure and access to the Moore Street parking lot.

The members were advised that the closure of Moore Street from Talbot Street to Centre Street would be needed from 7:00 p.m. to 1:00 a.m.

Mr. Cox, Lyndon Security was in attendance and expressed concern that his staff would not be able to access the Moore Street parking lot.

CONFIRMED_____CHAIRMAN

The members agreed to have access to the Moore Street parking lot through the emergency gate on the other side of the lot for parking and access for the businesses nearby only. A volunteer would be at the gate to let people in and out.

E. Taylor volunteered to let the Downtown Development Board members know about the current plans for the event.

The members discussed the potential for more games and that a resolution would be required from Council regarding future road closures.

Motion by T. Bridge – B. Hammersley:

THAT: The Special Events Committee supports the permit for the Jurassic Park Game 4 Viewing NBA Finals to be held on June 7th, 2019; and further,

THAT: The Parks, Recreation and Property Management Department be contacted regarding garbage cans, hydro requirements and an on-site meeting for the event; and further,

THAT: The Roads and Transportation Department provide barricades for the road closure from 7:00 p.m. to 1:00 a.m. on Moore Street from Talbot Street to Centre Street; and further,

THAT: Access to the Moore Street parking lot through the emergency gate be provided for accessibility parking and access for nearby businesses only with a volunteer at the gate; and further,

THAT: The St. Thomas Police Service provide two paid duty officers for the event; and further,

THAT: All other necessary requirements be fulfilled to the satisfaction of the Corporation of the City of St. Thomas.

Seniors' Picnic in the Park - July 10, 2019

A. Jefferson stated that an on-site meeting was held with the organizer.

K. English advised that the insurance certificate be provided to the Treasury Department.

S. Saini asked about food vendors.

Mr. Campbell stated that the food vendors would be the same as in past years.

M. Vriens stated that a report regarding bus transportation would go to Council on June 17th, 2019 which may require a detour due to the construction on Elm Street.

B. Todd stated that fire inspections would be completed prior to the start of the event.
