SPECIAL MEETING

NEW BUSINESS

Heritage Alteration Permit HAP-01-21 - 389-393 Talbot Street

Mr. Dane Moffatt and Mr. Craig Hansford, 389-393 Talbot Street provided an overview of the Heritage Alteration Permit application.

The members inquired about the brick columns on the storefront level.

Mr. Hansford advised that they believe the original brick columns still exist but are covered by the façade brick in front.

Heritage Impact Statement - 25 St. Catharine Street

He further advised that amendments to the original site plan now allow for additional greenspace and connection to the trail system due to the sharing of an entrance driveway with the property owner beside the proposed development.
