<u>DDB Tree Lighting Celebration - St. Thomas Downtown Development Board - November 19, 2021</u>

Mr. Earl Taylor, Chair, St. Thomas Downtown Development Board provided an overview of the event. He advised that no food or drinks would be served this year.

Mr. Taylor advised that the lights would be installed the week before the event.

The Lead Hand Building Maintenance asked that an e-mail be sent confirming the date of installation so that the adjacent parking spots can be blocked off.

6th meeting - Special Events Committee - 3

Reverse Santa Claus Parade - City of St. Thomas, MP, MPP, Optimists - December 3-5, 2021

Mr. Taylor provided an overview of the event and that this would replace the traditional Optimist Club of St. Thomas Santa Claus Parade this year.

Mr. Taylor advised that the displays would use generators for power and that a layout would be provided once the number of displays is confirmed.

The members discussed some issues last year relating to hydro where speeches were made and traffic congestion getting into the park.

Mr. Kyle Johnstone, St Thomas Police Department advised that discussions about traffic measures have been ongoing and that the Elm and Wilson intersection creates the most problems. He further advised that it was being considered to have cars enter from the west only and use both lanes of Elm Street as exit lanes.

The members discussed potentially blocking traffic at Elm and Elmina Streets.

Mr. Johnstone advised that officers would be available to assist and that he would also work with EMS to notify them.

THAT: The Special Events Committee supports the permit for the Reverse Santa Claus Parade to be held December 3-5, 2021; and further,

THAT: Southwestern Public Health be contacted regarding a plan for reducing the spread of COVID-19 at the event; and further,

THAT: St. Thomas Police Service be contacted regarding traffic control for the event; and further,

THAT: The Parks, Recreation and Property Management Department be contacted regarding hydro requirements for the event; and further,

THAT: All other necessary requirements be fulfilled to the satisfaction of the Corporation of the City of St. Thomas.
