THAT: The certificate of insurance be submitted to the Treasury Department prior to the start of the event; and further,

THAT: The Environmental Services Department be contacted regarding recycling containers and collection for the event; and further,

THAT: Documentation be provided that First Aid services have been confirmed for the event; and further,

THAT: An application to erect tents on the airport property be made to the Airport Superintendent; and further,
