St. Thomas-Elgin Recruitment Committee
Update Report
March 2023

Activities:

- 1) On March 6th Barbara Bailey and Chantal Sorhaindo representatives from the Nurse Practitioner's Association provided an excellent educational session to our committee utilizing zoom. I sent a thank you note to both of them and also requested their assistance to provide us with the tool kit and samples of a proposal they suggested during their presentation that our committee submit to be considered to provide a Nurse Practitioner Led Clinic (NPLC) in Elgin County. The documents have arrived and the next steps for completing them are being discussed. In an effort to obtain examples on what a successful application contains, I have arranged a telephone conversation with Stephanie Nevins the Clinical Manager with the Ingersoll NPLC. On April 12th. A list of questions has been prepared and hopefully they will share their submission with us as a template for ours to follow.
- 2) On March 9th Sandra and I met with Dr. Annie Keeler the President of the St. Thomas Elgin Medical Association (STEMA). The purpose of the meeting was to share with STEMA the suggestions received from the two new physicians who provided our committee with feedback. Dr. Keeler was taking this info back to the STEMA Executive for further discussion and will advise if any further action can occur. STEMA has advised that they will be hosting the annual Dr. McLay Miller dinner this year on April 22 ND. They have requested the sponsorship from our committee they have received in the past and once again have extended to me an invitation to attend. They will also provide a complimentary invitation to 2 Residents who have expressed an interest in practice opportunities in St. Thomas and Elgin County.
- 3) I'm pleased to advise that I met with a Resident doing her placement here in St. Thomas with a preceptor. We reviewed what practice opportunities are available. She is looking to do a 50/50 split between Family Medicine and Obstetrics. She will be ready to start practicing in Dec. 2023. Some additional research is required on her part to determine if Obstetrical practice is possible and she will be reaching out to the appropriate individuals for help to make this determination. We have agreed to stay in touch to see how her plans are working out.
- 4) In March I made contact with three local students attending Medical School outside of Canada. I shared with them the changes taking place in the 2023 Scholarship application criteria as it relates to eligibility. Applications from local students attending a Canadian accredited medical school outside of Canada will now be accepted. This change will be incorporated into the applications being posted in October. At the present time we now have 7 local students attending a medical school outside of Canada.
- 5) In March I had requests from 2 of our physicians for assistance & or direction on how they could find qualified office staff. I reached out to Anderson College and have put them in contact with

the appropriate individual. Anderson College amalgamated with Westervelt College recently, however they are maintaining the same arrangement with us to allow our Physicians to post ads for their Medical Office Administration requirements. I'm following up with these physicians to see if they would like to participate in the "Practicum Program" where students are required to complete an off-site externship placement. I'm also initiating a conversation with Anderson's Career Services Manager to see if the content of their program could be enhanced to assist physicians in any way with the paperwork burden. I have also reached out to Fanshawe College to organize the same arrangements.

- 6) Unfortunately the event planned by Dr. Haruta for March 18th for the "Meet & Greet" has been postponed. Several of the Residents and Physicians who had planned to attend are still very interested and will look forward to the event to be rescheduled in May.
- 7) Requests for telephone meetings were sent to 6 Residents doing placements at STEGH from March 14-April 10th. Conversations have occurred with 2 so far and follow up will be taking place before the end of their placements.
- 8) I have reached out to Sheri Nolan with a reminder to include us in the distribution of the ST. Thomas Elgin General Hospital's 2023 Summer Medical Bursary Opportunity notice which is usually sent out in April as our committee would be happy to help distribute this opportunity to contacts we have with First and Second year Medical Students.
- 9) Some of the activities that occurred this month were actions suggested in the Feedback from Physicians "Suggestions and Recommendations document". Feedback and analysis will be updated in the document and will continue to be shared with the committee as action occurs.

Background:

The Elgin-St. Thomas community has been active in the recruitment of family physicians since 2008. The Health Recruitment Partnership, a collaboration of Elgin County, the City of St. Thomas, physicians and several key community stakeholders has been meeting since that time. With the help of a dedicated recruiter, medical leaders have been attracted and established practices within this community.


At a recent meeting of the Elgin St. Thomas Health Recruitment Partnership, a request to receive an overview of the incentive grants provided under the program was requested. Attached is the listing of recipients and grant amounts.

Highlights include:

- First grant allocated in 2008; most recent grant in 2022 for initiation in March 2023
- Thirty-five (35) grant agreements have been created to support 36 physicians and 1 nurse practitioner
- The majority have received the current maximum amount of \$33,000
- A total of \$1,123,280 has been allocated from 2008 to 2023 (to date)

Funds allocated through this program, which are cost shared between the Elgin County and St. Thomas, have help to effectively create opportunities for medical professionals and ensure needed services for local citizens.
