## Elysian Street Construction St. George Street to Penwarden Street Public Information Centre

The City of St. Thomas has finalized the design of the Elysian Street Construction project with construction expected to begin in the spring of 2024. The work includes replacement of sanitary sewers, watermain, storm sewers, roadwork, curb and sidewalk along Elysian Street from St. George Street to Penwarden Street, and East Street from Elysian Street to the North Limits. The Elysian Street Construction project implements the City's "Complete Streets" philosophy to enhance accessibility for all road users including vehicles, cyclists, and pedestrians of all ages and abilities. Sidewalk located on the south side of Elysian Street will be removed to provide enough space within the right of way for boulevard and accessible sidewalk on the north side of Elysian Street meeting the AODA criteria.

In conjunction with the work on Elysian Street, the City plans to change Pearl Street from one-way to two way traffic. Existing on-street parking on Pearl Street will remain in place with no changes.

We invite you to a drop-in style Public Information Centre where you can learn more about this project, view the plans and discuss the proposed improvements with City staff.
