## **Basic Eligibility Requirements**

You must be a Canadian citizen, Landed Immigrant, or have Refugee Claimant Status, or you have made application for status as a permanent resident under the *Immigration and Refugee Protection Act (Canada)* or for refugee protection under the *Immigration and Refugee Protection Act (Canada)*, and no removal order has become enforceable against any member of the household under the Act.

If you own a house, any offer of rental accommodation as a result of this application will be conditional upon you listing your house for sale. If sale of the house is not completed within six months of accepting accommodation, you will not be eligible to continue receiving RGI assistance (exceptions <u>may</u> be made in extenuating circumstances or if a sale is imminent).

You must not owe rent or damage arrears to any social housing provider. (Exceptions <u>may</u> be made in extenuating circumstances or if an agreement to repay is in place.)

At least one person in your household must be 16 years of age or older, and able to live independently with or without support services.

No member of your household has been convicted during the past two years of an offence arising from misrepresentation of income for rent-geared-to-income purposes.

#### **Subsidized Housing**

For all of the <u>social housing</u> projects which are listed above on this application the rental subsidy is the difference between the "geared to income" rent, and the "market rent" for the tenant's unit. The monthly rent the tenant pays is approximately 30% of their gross monthly income, but lower than that if they pay their own utilities, and slightly higher if they don't. The balance of the rent for their unit is paid by a subsidy for the tenant which is received directly by the housing provider.

#### **Portable Housing Benefit**

A Portable Housing Benefit (PHB) is a monthly financial benefit which is calculated based on family composition and household income. A PHB can be used by the recipient to assist them with rental and utilities costs in any residential housing unit within St. Thomas and Elgin County.

#### **City-Owned Affordable Housing**

"Affordable housing" is housing where the rent paid by the tenant is not based on their income but is set at 80% of the average market rent for each size and type of unit within the community where the housing is located. Currently there are only 1 BR affordable housing units available.

The affordable rent for a 1 BR apartment in St. Thomas in 2020 is \$580/month
