6:50 p.m. The Mayor called the meeting to order and stated that this is a public meeting as required by the Planning Act to afford any person an opportunity to make representation with respect to a proposed Draft Plan of Subdivision (File No. 34T-04510) which will permit the development of 20 lots for single detached dwellings and 14 lots for the development of 28 semi-detached dwelling units on a proposed southerly extension of Faith Boulevard.

The Mayor then asked if any members of Council had a Disclosure of Interest concerning the Draft Plan of Subdivision.

The Deputy Clerk stated that notice was given in the St. Thomas Times Journal on Saturday, January 22nd, 2005.

The Planner, Jim McCoomb, then explained to the members that the applicants are proposing to develop the site as a residential Plan of Subdivision, containing a total of 20 lots for single detached dwellings and 14 lots for the development of 28 semi-detached dwelling units.
