2005 Budget

Alderman Barwick read his letter of submittal relating to the Budget.

The Director of Finance and City Treasurer provided a power point presentation which highlighted the City’s financial position in relationship to other like size communities and also provided a forecast relating to the City’s finances in future years.

The members commended Alderman Barwick, Mayor Kohler and staff for all of their work in developing the budget.

Alderman Turvey inquired about the effect of the budget on property taxes.

Alderman Barwick stated that the combined municipal and education increase would be 3.1 percent for residential.

Alderman Shackelton requested, and Council by consensus concurred, that the Director of Finance and City Treasurer check to see if the City was required by the Province to have a Tax Stabilization Reserve.

Alderman Shackelton inquired about the inclusion of \$60,000 for the decommissioning of Northside Arena.

The Director of Finance and City Treasurer responded that a report would be coming to Council in the near future regarding Northside Arena.

Alderman Barwick stated that it was better to have some funds identified rather than try to find them later.

Alderman Shackelton inquired about the reduction in the transit portion of the budget.

The Supervisor of Roads and Transportation commented that this reduction was a good news story because of increased revenue streams.

Alderman Turvey recommended that in the future a separate list be provided of all grants being provided within the budget.

Alderman Shackelton suggested, and Council concurred, that the Director of Finance and City Treasurer be directed to review the concept of providing funds to the Community Foundation in lieu of direct grants from within the City's budget.

Alderman Shackelton suggested, and Council concurred, that staff be directed to review the existing costs associated with the contracting out work to see if there were any efficiencies to be made by bringing the work in house.

Alderman Aarts inquired about the effect of extending the debt timeline further for the St. Thomas-Elgin Community Centre / Twin Pad Arena.

The Director of Finance and City Treasurer responded that this would increase the interest costs and that he believed that the shorter time frame for this project was fiscally responsible.

Alderman Turvey inquired about the amount of funds allocated for sidewalk work.

Alderman Barwick stated that once Council members understood the level of COMRIF funding they might be able to consider a larger allocation to sidewalks.

Mayor Kohler stated that it would be valuable for Council to have an understanding about the final reserve amounts that the City should have.

Vehicle and Equipment Replacement Reserve
