Zoning By-Law Amendment - Add "clinic" as an additional permitted use within the Downtown Commercial Zones (C1, C2, C3)

6:45 p.m. Mayor Kohler called the meeting to order and stated that this is a public meeting as required by the Planning Act to afford any person an opportunity to make representation with respect to a proposed zoning by-law amendment which will add "clinic" as an additional permitted use in the Downtown Talbot West (C1), Downtown Talbot Central (C2) and Downtown Talbot East (C3) commercial zones.
