Mr. Habkirk provided an overview of the 2006 MedQuest Camp and asked Council to consider a budget allocation of \$5000.00 for the 2007 MedQuest Camp.

Mr. Habkirk and Mr. Malik presented Ms. Murray with a token of appreciation for her work in the area of health recruitment in the St. Thomas-Elgin area.

### Cowan Park - Restrooms and Pavilion

Ms. Polland requested that a fence at 66 Regent Street be removed and that the City not consider entering into a lease with the property owner to use the land.

The Director, Environmental Services confirmed that a letter had been sent to the property owner on June 6th requesting that the fence be removed. Further, he stated that the City was working to bring a solution to this matter and that the original request to remove the fence was still in place.

Request for Proposal - Engineering Design of Emergency Standby Power at the Water Pollution Control Plant

Mr. Mike Newbigging, President, Hydromantis, Inc. was in attendance to discuss the request for proposal for Emergency Stand By Power Design at the St. Thomas Water Pollution Control Plant.

Mr. Newbigging expressed concern over the City's policies relating to the receipt of tenders that were delivered by courier to the City in that the engineering firms had no control over the date of delivery once a package had left their office for delivery. He also expressed concern about the weighting of costs in the overall scoring of engineering proposals versus the weight given to the experience and expertise of consulting engineering firms.
