The members expressed concern that the objectives of the recently completed Ridership Strategy Program would not be initiated because the rolling stock was required.

The members requested additional information relating to the need for a new road grader.

The Director of Finance and City Treasurer informed the members that the acquisition of equipment was a two step process which required approval within a capital budget and then confirmation through the tendering process which would include a report back to Council.

The members discussed the fact that the facility needs of the St. Thomas Police Services were very important and that they needed to be addressed.

The members discussed the proposed expenditure at Memorial Arena in relationship to the existing land lease with the Federal Government.

The Director of Finance and City Treasurer stated that he would contact the Federal Government regarding the lease.

The members discussed the proposed expenditure for the Faith Baptist Park Development Partnership.

The members, by consensus, directed that staff develop a report, which defines the current status of partnerships that the City has with groups and service clubs in the development of city parks.
