

THAT: Council receive Report No. TR-13-07.

THAT: Council accept the Tender submitted by J&A Cleaning Solutions Ltd. In the amount of \$139,334.88 (including GST) for Janitorial Services at the Justice Building for a two year period.

THAT: Council approve \$15,000 as an unbudgeted expenditure in 2007 and that such amount be included in the June 30th budget monitoring report.

THAT: A by-law be prepared to authorize the Mayor and Clerk to sign an agreement with J&A Cleaning Solutions Ltd. for this contract award.

Background:

The Tender for Janitorial Services closed on Tuesday, January 23, 2007 at 2:00:00 p.m. and all bids received were immediately opened in public in the lower conference room. Two bids were received from the following companies:

Tender Amount

Omni Facility Services Canada \$ 108,533.64 J&A Cleaning Solutions Ltd. \$ 139,334.88

The Tenders were checked for the mandatory response requirements and were checked for calculation errors. Both bids received were compliant with our requirements and no calculation errors were found. Purchasing and Facilities staff reviewed the bid responses and recommended on January 30th, 2007 the contract be awarded to the low bidder, Omni Facility Services Canada, in the amount of \$108,533.64 for a two-year period.

Since that time Omni Facility Services Canada has encountered many difficulties in fulfilling its contractual responsibilities. Omni's Inability to acquire enough sultable staff and its fear that it might lose its performance bond has caused it to withdraw its bid and has chosen not to accept the Janitorial Contract.

Therefore it is recommended that the contract be awarded to the next highest bidder in the amount of \$ 139,334.88, J&A Cleaning Solutions Ltd. An additional unbudgeted expenditure for this contract in the amount of \$15,000 is required. It is requested that this amount be approved by Council and included in the June 30th budget monitoring report.

Due to the current condition of the building, Hickman Mount Reconstruction Inc. has been retained by the City to provide a "construction/renovation cleanup" whereby the facility will be cleaned based on priorities and funding availability.

The Police Chief has been consulted and concurs with our recommendations. Staff are available to answer any questions members may have.







Dear Mayor Barwick:

Thank you for your letters of February 6 and March 15, 2007, requesting that the Government of Ontario purchase that part of Canadian National's CASO Subdivision railway line from mile 113.64 to mile 117.49 in the City of St. Thomas.

I have already advised Canadian National that the Government of Ontario declines to purchase the above noted portion of CN's CASO Subdivision railway line. The Ministry of Transportation does not have formal programs to fund short line railway infrastructure or to purchase discontinued railway lines.

Having said that, I am aware of the potential tourism impact of the railway heritage aspect of the railway line running through St. Thomas. Accordingly, I would suggest that you explore this with the Ministry of Tourism. I have copied the Honourable Jim Bradley on this letter. You may wish to outline the tourism potential here and provide some examples of how the retention of the rail line could showcase the railway heritage of St. Thomas.

As you will read in his letter, Mayor Barwick has written to Minister Cansfield to request that her ministry consider purchasing railway lands within the City of St. Thomas that are being divested by CN Rail. These lands are vitally important to planned future development within the city that has the potential to reinvigorate downtown St. Thomas.

My constituency staff and I have investigated any existing provincial government funding programs that could assist the City of St. Thomas in finding a way to purchase this parcel of land. Unfortunately, there are no current programs that can assist the City of St. Thomas in this regard other than the Canadian Strategic Infrastructure Fund Assistance program and this program will not be of use due to the extremely short timeframe the city has to make a decision on a future plan of action before CN can officially divest the parcel of land.

I am writing to all of you today because I believe your ministries have the most jurisdiction or interest in this matter. I would appreciate your reviewing this matter and providing any advice or assistance available that could help the City of St. Thomas with its pressing situation. As you can appreciate, time is of the essence in this matter and your quick response is appreciated.

Dear Mayor Barwick:

The McGuinty government is reaffirming its commitment to brownfield redevelopment. As announced in the 2007 Ontario Budget, we are acting to revitalize communities and put more vacant and under-utilized sites back to productive uses.

The proposed comprehensive brownfield reform package would, if passed, address barriers to brownfield reform and help ensure that the public interest remains protected.

In consultations we had with you in the past year, we heard your concerns about barriers to redevelopment. We are delivering with these proposed reforms.

The proposed legislative brownfield reform package would, if passed:

- protect developers and consultants involved in cleaning contaminated lands from provincial clean-up orders, if they were not responsible for the contamination
- protect municipalities from civil lawsuits relating to planning approval and building permit decisions, where the lawsuits solely arise from inaccuracies in filed clean-up documentation
- allow the government to take steps when and where appropriate to ensure public health and safety are protected
- protect companies involved in abandoned mine remediation from provincial clean-up orders, as long as the company was not the cause of the contamination
- allow for upfront provincial review of clean-up work to ensure appropriate standards are met.



Dear Friends,

In June 2005, the *Accessibility for Ontarians with Disabilities Act* (AODA) was made law. The purpose of the legislation is to develop, implement, and enforce accessibility standards in order to achieve accessibility for Ontarians with disabilities with respect to goods, services, facilities, accommodation, employment, buildings, structures and premises on or before January 1, 2025.

In February 2006 the Accessibility Directorate of Ontario began implementing this legislation by establishing the first two Standards Development Committees on Customer Service and Transportation. A third committee on Information and Communications will hold its first meeting later this month.

The Accessibility Directorate of Ontario has been working closely with the lead ministries of Municipal Affairs and Housing and Labour to prepare for the Accessible Built Environment and the Employment Accessibility Standards Development Committees.

We are now ready to call for qualified members to serve on these next two committees. The Accessible Built Environment committee will look at the barriers in the physical environment, both Indoors and outdoors, as well as issues such as clear signage and parking. The Employment Accessibility committee will look at how people with disabilities can be given an equal opportunity to apply for jobs and ways in which workplace policies and practices can be made more inclusive.

I am writing at this time to let you know about the next steps in the process.

Recruitment for each Standards Development Committee is taking place simultaneously from April 8th to May 8th 2007. Application forms and terms of reference for each committee are available on the Ministry of Community and Social Services website at http://www.mcss.gov.on.ca/mcss/english/pillars/accessibilityOntario and in French at http://www.mcss.gov.on.ca/mcss/french/pillars/accessibilityOntario/index.

For additional information, or for application packages in alternate formats, such as large print, audio formats (cassettes or cd's), or Braille please call 1-888-789-4199 or toll-free TTY 1-888-335-6611.

Consistent with the AODA, members of these Standards Development Committees must include people with disabilities or their representatives, representatives from industries, sectors of the economy or organizations that will be affected by the proposed standard and representatives from government ministries.
