The applicant is requesting the following minor variance:

(i) To permit a westerly interior side yard depth of 2m, whereas the City of St. Thomas Zoning By-Law No. 50-88 (Table 2 to Subsection 8.4, Item Number 11(a), Column 4) requires a minimum interior side yard depth of 4.5m.

Collier Homes Inc. is proposing to construct a six unit apartment building on the subject lands, which is permitted by the Fourth Residential Zone (R4).
